Such extension of period of posting on deputation basis would be subject to his/ her performance, concurrence of his/ her parent Commissionerate and approval of the Competent Authority.

3. It may also be brought to knowledge of the willing officers that in the event of selection, He/ she will not be allowed to withdraw his/ her name.

4. In case the work and conduct of the officer is not found satisfactory while working in the directorate, he/ she is likely to be reverted to his / her parent Commissionerate before the completion of the deputation period.
