Ghaziabad/Dehradun.**


The Directorate General of Goods & Service Tax Intelligence, Meerut Zonal Unit (DGGI, MeZU) is in the process of drawing a panel of willing and suitable officers for filling up the existing vacancies in Meerut Zonal Unit including its Regional Units in the grade of Intelligence Officer. For this, there are 02 anticipated vacancies on deputation basis and the vacancies on loan basis would be filled up on the basis of NOC and vigilance clearance certificates received from concerned zone.

2. It is proposed to fill up the vacancies by appointing willing and suitable officer on Loan/Deputation basis, for the period of Two/five years as case may be, from the grade of Inspector. The officer, who has been granted financial up-gradation under MACP, is also eligible to apply.
3. It may be made clear to the willing officer that the option once given would be final and in the event of selection, he /she will not be allowed to withdraw the same.
4. It is requested that the circular may be brought to the notice of all the formations in your jurisdiction and the application of willing officer may be forwarded to this Zonal Unit. While forwarding the name of the willing officer the following information in respect of him/her may also be sent for evaluation by this Directorate.

1. Complete Bio-Data and willingness of the officer.
2. History of Posting.
3. No Objection Certificate from Chief Commissioner's office to relieve in the event of his /her selection.
4. APAR grading for the last 5 years.
5. Vigilance Clearance Certificate.
