Engagement of Full time/Part Time Super Specialist will be initially for a period of one year and may be renewed/extended on a yearly basis for a total period of 3 years or till joining of regular incumbent or attaining 70 years of age, whichever is earlier.

For Part Time Super Specialists: -

Terms and condition:-

In case of Full Time/Part Time Super Specialist, the engagement will be for a minimum period of **three years** ortilljoining of regularincumbent or attaining 70 years or age, whichever is earlier. The contract would be extendable yearly based on satisfactory performance.

- (a) The Full time Super Specialist should be available on call 24X7. The Part time Super Specialist should be available 24 X 7 if they submit their willingness for emergency visit.
- (b) The Super Specialist shall be responsible for all cases undergoing treatment under his supervision in that specialtydiscipline.

(c) The Selected Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be
(1) Rs.30 lakh for Anesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic Surgeons etc.
(2) Rs. 20 lakhs for General Surgeons, Gynecologist, Obstetrician etc.
(3) For Physicians Dentists, Radiologists, Pathologists etc. it should be at least of Rs. 10

(3) For Physicians Dentists, Radiologists, Pathologists etc. It should be at least of Rs. 10 lakhs. A copy of the Insurance & Premium and receipt must be submitted within 7 days from the date of engagement.

- (d) Selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.
- (e) The Full time Super Specialist is entitled for the leave @ 04 days for each month of work on a pro rata bas is in a calendar year.
- (f) Minimum working hour in respect of Part Time Specialist hour will be 16 per week as per directions of MS/Dean
- (g) The Part time Super Specialist will not be entitled for any kind of leave benefits.
- (h) The appointment is subject to Medical Fitness.
- (i) No TA/DA will be admissible for attending the interview/joining thepost.
- (j) The selected Full Time/Part Time Super Specialist will be required to submit acceptance/consent letter in writing before appearing for Medical examination.
- (k) The appointing authority reserves the right to terminate the appointee anytime even before the tenure without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
- (l) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- (m) Selected candidates will join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued, failing which the offer letter will be treated as cancelled.
- (n) Fulltime/Part-time Super Specialist has to wear his/her own white coat with name badge during the duty hours.
- (o) He/ She will be required to mark attendance manually as well as AEBAS (Aadhar Enabled Based Bio Metric Attendance System)
- (p) Candidates are requested to bring their original certificate in evidence of age of proof (date of birth), educational qualification, medical council registration of the state/MCI, experience certificate along with one set of self - attested photocopies with 2 recent passport size photographs at the time of document verification.
- (q) Private practice of any kind will not be allowed (except for part time specialist/super specialist).
- (r) The contract will be signed on a stamp paper of Rs. 100/-. The original contract will be with the hospital and its copy will be with candidate. Cost of the stamp paper will be borne by the candidate.

- (s) The Full time Super specialist/Specialist will be required to deposit security of Rs. 35000/-(Rupees Thirty Five Thousand only) through Demand Draft in favour of ESI Fund Account No. 1 at the time of joining, which is refundable after completion of contract period and on production of "No dues certificate".
- (t) The contractual engagement may be terminated/discontinued on either side giving one month prior notice to this effect without assigning any reason.
- (u) In case of engagement of retired employees/pensioners, they may be allowed to draw full consolidated remuneration without any deduction as it is not a case of re-employment in terms of Central Civil Services (Fixation of Pay of Re-employed Pensioners) Orders. 1986 and the retired employees/pensioners can continue to draw pension and dearness relief on pension during their period of contractual engagement.
- (v) Hostel accommodation/quarters will not be provided.
- (w) In case of Part time Super specialist, the amount of fixed remuneration will be applicable upto 100 new cases, 100 old cases and 50 IPD cases, per month. Beyond this will be charged as per CGHS rate. Cross Reference charges of indoor ward patients from broad specialties to be paid @ of OPD consultation charges.

B. <u>HOW TO APPLY:-</u>

Interested candidate should attend the interview with filled in Application Form (Annexure- II) and enclosing necessary self-attested copies of certificates, as mentioned below:

- b) Two copies of recent self-attested color passport sizephotograph.
- c) One set of self-attested copies of certificates and testimonials in support of:(i) proof of age (Date of Birth),(ii)Category(SC&ST),Category OBC in updated Government of India Format, Sub-category,
 (iii) Educational Qualifications: (Matriculation, Higher Secondary, Graduate, Post Graduate, & any other),(iv) Registration certificate issued by State Medical Council/MCI, (viii) NOC for in service candidate from employer, (ix) Service bond release certificate if applicable along with Original documents

C. <u>Selection Procedure:</u>

- i. The selection will be made on the basis of performance of the candidate in interview beforethe SelectionBoard.

D. <u>General Conditions:</u>


