ADDITIONAL TERMS AND CONDITIONS

1. The institution will be responsible for providing qualified Yoga Instructor to ESIC Hospital, Vapi, Gujarat. No individual Yoga instructor will be appointed i.e. it is a contract for service instead of contract of service.
2. The Yoga instructor engaged through this institution shall perform his/her duty as per Hospital working hours **9am to 4pm on weekdays and 9am to 1 pm on Saturdays(Sunday closed holiday)**. There will be lunch break from 1.00 pm to 1.30 pm. One casual Leave per month and all holiday declared by the hospital will be admissible to the instructor provided.
3. The monthly remuneration for Yoga instructor will be **RS.32,000/- (Rupees Thirty Two Thousand Only)** for full time and payment will be made to the Yoga Institutions /NGO.
4. Initially the Yoga instructor shall be engaged for one year but can be extended on yearly basis up to 3 years subject to satisfactory work on mutually agreed terms.
