Qualification and experience should be in relevant discipline/field and from a reputed institution/organization recognized by relevant authority.

4. Experience shall be counted from the date of completion of minimum essential educational qualification. Submission of incorrect or false information during the process of walk-in interview shall disqualify the candidature at any stage.

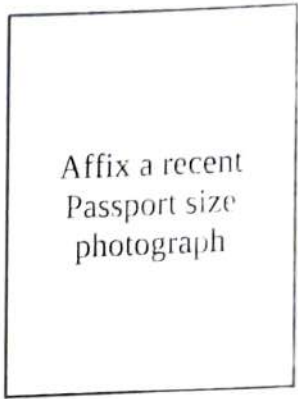
